5.0 SUPERINTENDENT'S REPORT/DISCUSSION

5.1 Report & Discussion of District Activities - Dr. Mizell

Dr. Mizell provided a typed report to Board Members during the workshop detailing updates for the Maintenance Department, Athletic Events and Personnel News. Dr. Mizell reviewed what was discussed in the workshop. Upcoming District projects to include Blanco HVAC EBI system upgrades and using old HVAC parts throughout the District. Intercom systems to be installed at BHS and MAJH. Materials for the BHS auditorium roof will soon be available to complete this project. Also mentioned was the re-keying of District classrooms so teachers can lock the doors from inside the classrooms. Upcoming training for AED's, once training is complete, the AED's will be installed throughout the District. Remodeling of the family resource center will start this summer. BHS track to be replaced starting May 20th. Summer project are underway. The District is currently hiring for many positions. Dr. Mizell thanked everyone in attendance for their support.

6.0 PRESENTATIONS

6.1 Board of Education Scholarships - Mr. Maes

The scholarships will be a one-time award, paid directly to the student's school of choice after the students has presented proof of registration. It is the Board's belief that we need to encourage student scholarship by supporting the development of strong community members. One scholarship will be awarded to a student planning on entering any educational field. A second scholarship will be awarded to a student entering any college degree program or a technical field certification.

Mr. Maes greeted the board and audience. He noted that the Board had received six Board of Education Scholarship applications. The Board reviewed applicants and looked for community involvement, GPA and teacher letters. This year the Board selected Elias Gunn and Adan Benavidez. Both were present to receive the scholarships. Congratulation to both.

6.2 NMSBA Excellence in Student Achievement Award - Mr. Maes

This award, sponsored by the New Mexico School Board Association (NMSBA), is presented to individuals selected by the local board of education who have played an important role in improving student achievement in their local school district.

Mr. Maes read the nomination letter out loud to the Board and audience. The recipient has worked for the District for over 30 years, first as a EA, a preschool teacher, kindergarten teacher and now as a teacher leader. She is a teacher mentor and is highly respected by all who know her. This year the award is presented to Bette Stahle. Mrs. Stahle was in attendance to receive the award. Mrs. Sharp stated the students and staff appreciate Mrs. Stahle. Dr. Mizell also stated her appreciation to Mrs. Stahle.

6.3 Sally Martinez Memorial Scholarships - Mrs. Spencer

The scholarships will be a one-time award. Recipients must graduate in good standing from BHS or CYB and have attended at least one year at Blanco Elementary. This scholarship is in honor of Mrs. Sally Martinez who had a love for teaching and was known for her kind heartedness.

Mrs. Spencer greeted the board and audience. She mentioned that Mrs. Sally Martinez taught in Blanco for 14 years. Mrs. Martinez passed away of covid in 2020 and now this scholarship is given in her name to honor her legacy. Mrs. Spencer turned the floor over Mr. Martinez to say a few words. Mr. Martinez thanked Dr. Mizell, the Board and Mrs. Spencer for all their help and support. Mrs. Spencer presented this year's two scholarships to Adan Benavidez and Annika Page. Annika will be attending UNM in the fall to study nursing. Congratulations to both recipients.

6.4 Retirement Plaques - Mr. Maes

Present retirement plaques to show appreciation for hard work and dedication to the District. Mr. Maes turned the floor over to Dr. Mizell. Dr. Mizell stated to work in one District your entire career is very unusual these days and both of these men have committed themselves to this community, 25 years for Adam Benavidez and 30 years for Chad Burkholder. Dr. Mizell states both have been great administrators and a pleasure to work with and will be greatly missed. Dr. Mizell wished them the best in their future plans. She also mentions a special recognition to both for their service to Bloomfield School District and for being great educators. Dr. Mizell thanked both Mr. Benavidez and Mr. Burkholder. Mr. Benavidez and Mr. Burkholder were present to receive their retirement plaques. Happy retirement to both.

6.5 District Athletics - Mr. Tensay

District Athletics presentation to Board Members. Mr. Maes turned the floor over to Mr. Tensay to present on Bloomfield Schools District Athletics. Mr. Tensay presented a PowerPoint presentation to the board and audience. He discussed the organizational chart for District Athletics. The athletics department oversees the high school and junior high athletics, working with both principal, coordinators, trainers and athletic secretaries. Athletics has 12 program head coaches which includes the junior high. Total of 70 coaches district wide. Mr. Tensay mention he part of his duties include conflict resolution, media relations, NCAA contact, marketing/publicity, facilities and fundraisers. Mr. Tensay is also a NMAA/National AD Representative for our District and County. He also oversees the event and program management as an athletic director. Budget managing, eligibility and policy management are included in Mr. Tensay duties. Mr. Tensay mentioned providing professional development for coaches and staff to include new coach orientation and 1Vision 1Mision alignment. Mr. Tensay mentioned building relationships by getting to know the community and help the coaches feel valued are important. Dr. Mizell thanked Mr. Tensay for all his hard work.

Mr. Tensay turned the floor over to Tina Griego, the coach of co-ed cheer. She greeted the board and audience. She mentioned hosting a camp this year and more boys have been added to the team. The UNM coaches have been at many competition watching the boys on the co-ed team compete. Mrs. Griego thanked the board for their support.

Mrs. Corley the volleyball coach and assistant track coach, thanked Dr. Mizell and the board for all their support. She mentioned that there are not enough junior high volleyball athletes. Junior high level volleyball is new to these athletics. She mentioned the junior volleyball has grown over the years. The high school volleyball team was a young team but place third at the Sandia Prep tournament. Mrs. Corley mentioned planning a summer kids camp, hosting a camp with a college coach and going to team camps this summer.

Mr. Mosley the track and field coach stated that they treat track and field as a family. He mentions that we are the only school in the state of New Mexico that coaches the junior high athletes with the high school athletes. He also provided information from his top ten list of all the track and field events to the board and audience.

Mr. Mosley is very thankful for the new track that will be replaced this summer.

Mr. Nelson the softball coach thanked the board and the superintendent for all their support this season. He also thanks Mr. Tensay and Mrs. Lucero for their help and support too. He provided an update of the past four years coach the softball team. He mentions the softball team has been working hard this season as they prepare for the state tournament. Mr. Nelson thanked the rest of the softball coaching staff. The softball program is built on integrity, hard work and diversity.

Mr. Luster the wrestling coach provided an update on the wrestling program to the board and audience. He mentioned that this was his first year as head coach. Last year they had four female wrestlers, this year 22 females started and 10 females completed the season. Bloomfield wrestling had the first female state wrestling champion. An eighth grade placed second in state as well. Mr. Luster is expecting an excellent season for next year's female wrestlers. The boys wrestling program went to several tournaments in Arizona and received a lot of experience. This season, Bloomfield wrestling won District, won their first Region 1 Tournament and a half a point away from winning the State Championship. To complete the season, Bloomfield wrestling had five state champions, four males and one female. Mr. Luster thanked Mr. Tensay and the board.

Mr. Winward the cross country coach provided an update on the program to the board and audience. This year Bloomfield hosted a cross country event and many other coaches helped organize this event. He mentioned that this year was the first year cross country had a complete girls team. Mr. Winward thanked the board, Mr. Tensay and Mrs. Lucero for their support and help.

Mrs. Jones the girls' soccer coach provided an update on the program to the board and audience. Mrs. Jones states this year's program had 33 girls' soccer players. She mentioned the team defeated Kirtland in the first round of the playoffs then went to play Albuquerque Academy and finished third. She also mentioned that many soccer players are shared among different sports at Bloomfield High School. Mrs. Jones thanked everyone for all the support.

Mr. Rivers the girls' basketball coach provided an update on the program to the board and audience. To start off the year, a youth camp was presented, many youth players came to participate. Analyss Benally a college athlete was present at this event. The team participated in three tournaments this season. Placed fifth at the Shiprock tournament and first at the Cuba Tournament. The Lady Cats did make the state tournament, won against Highland then went to The Pit. Mr. Rivers stated that the program is based on four core values character, fundamentals, hard work and toughness. This summer the team will participate in two camps, one at Fort Lewis College and one in Phoenix, Arizona at the Cardinals Stadium. Mr. Rivers thanked Mr. Tensay, coaches, Dr. Mizell, and the board.

Mr. Belveal the baseball coach provided an update on the program to the board and audience. This season the team had nine eight graders on the JV team and ended the season with 16 wins. Varsity ended the season with 17 wins. He is very excited for next year's season. Mr. Belveal mention that 38 athletes participated this year. Varsity scored more runs than last year by 60 runs. Bloomfield had the first most valuable player in the District. Played four freshmen in the Artesia Tournament. Mr. Belveal stated he is honored to be part of the District and Bloomfield Athletics.

Mr. Richardson the boys' basketball coach provided an update on the program to the board and audience. The start of the season was up and down. Playing tough competition at the Hope Christian Tournament. Played against Artesia. The team made it to the District Championship game and were two possessions away from going to the state tournament. Four starting players will be back to play next year. Mr. Richardson thanked everyone for all their support.

Mr. Allcorn the athletic coordinator at Mesa Alta provided an update to the board and audience. He mentioned introducing the seventh and eighth graders to the athletic programs at the junior high level to prepare them for competing at the high school level. He encouraged coaches to continue to promote student athletes. Mr. Allcorn thanked everyone for their support.

Mr. Stovall the BHS dean of students and athletic coordinator provided an update to the board and audience. He mentioned that student academics is important including respect to others. He will be working on the

Bloomfield Pals program which includes student athletes go to an elementary school wearing their sports jersey and reading to students. Mr. Stovall also mentioned being present at sporting events to supervise as the athletic coordinator. He states that coaches need to building relationships that are positive for the kids. So the kids have a fun experience that builds character, confidence and self-esteem. Mr. Stovall thanked everyone for their support.

Mr. Kovacs the football coach provided an update on the program to the board and audience. Mr. Tensay mentioned that Tri City Record has named coach Kovacs "Coach of the Year". He has been coaching for 31 years. He has planned many youth camps and will continue this summer. At last year's football camp, 130 youth football players attended this event. Bloomfield has a very successful Yafl program. The seven on seven football event will be in July, everyone is welcome to come and watch. 400 kids plan to attend and is an all-day event. Mr. Kovacs thanked the Board, Dr. Mizell, Mr. Tensay, coaches and audience.
