2.7 Facility Master Plan 2024-2029 - Mr. Olivas

The five-year Facilities Master Plan is due for an update. All school districts are required to have a master plan on file in order to receive funding and grants. BSD Facilities Master Plan was presented at the September 10, 2024 Board Workshop.

2.8 Preventative Maintenance Plan 24-25SY - Mrs. Olivas

Updated the Bloomfield School District Preventative Maintenance Plan for PSFA submission, this is a yearly requirement. The annual Preventative Maintenance Plan must be reviewed and approved by the Superintendent and Board of Education.

2.9 Special Education EA at Central Primary - Mrs. Benavidez

Central Primary has more non-verbal and behavioral students who require more supervision this year. Special Education students are required to be exposed to core curriculum. Some students are able to attend their regular education classroom with no supervision but there are a few who need an adult to supervise them. The additional staff member will ensure that special education students are participating in the regular education classroom.

3.0 DISCUSSION and REVIEW ITEMS

3.1 General Obligation BOND 3 - San Juan College

Mr. Summers turned the floor over to the San Juan College Dean of Students, Yolanda Benally, to present a PowerPoint on the 2024 State Bond 3. This is a statewide bond, that invests in higher education throughout New Mexico. Mrs. Benally also provided demographics and the mission and vision of San Juan College. She also showed the graduation percentage throughout the years for San Juan College. The 2022 State GO Bond funded projects included replacing cabling, fiber and internet security for students and employees. Completed 2022 State GO bond includes the Bike Park Pump Track, Henderson Fine Arts Center Theatre Rigging, Connie Gotsch Theatre Fire Retardant Curtains, and the Health and Human Performance Center Retractable Bleachers. She mentioned the 2024 State GO Bond 3 will benefit public colleges, universities and specialty

schools. San Juan County would receive \$5.5 million, \$1.25 Million to Agricultural Science Center at Farmington, \$1 million to Dine College and \$3.25 million to San Juan College. The San Juan College 2024 proposed projects include the upgrade of three boilers and units, replace heating and cooling controllers. The State GO Bond 2 is a state bond for libraries. Yolanda also provided election day and voter information. She thanked everyone for allowing her to present.

3.2 Policy Review IJOA Field Trips - Mr. Summers

Policy IJOA Field Trip has been edited and will be reviewed by the Board of Education. The Policy will be up for approval at the November 12, 2024 Board of Education meeting.

3.3 Equity Council Update - Mr. Summers

3.4 Report & Discussion of District Activities - Mr. Summers

Mr. Summers provided a typed report to Board Members detailing updates from the maintenance department, District athletics and personnel news. Mr. Summers mentioned the Bloomfield Aquatic Center skylight replacement is searching for a vendor to work with the City of Bloomfield, this project will go out for bid. He also mentioned a PSFA meeting to be held on November 12th in Santa Fe, New Mexico. Dale Maes, Staci Babcock, James Olivas and Kevin Summers will attend the PSFA meeting. The November 2024 Board meeting will be held on November 19th.
