1.0 CALL TO ORDER

Mr. Summers stated the BECC travel will be funded by grants, no cost to the District. Mr. Maes stated he thought the RCA travel was finished. Mr. Summers said there will be one more group going to RCA in March. Then the Title II funds will be reconciled which have been used to fund the RCA travel. Another group may be sent in June. Ms. Babcock mentioned the Title II grant will end June 30, 2025, until next year's allocations.

2.4 Finance Committee Briefing - Ms. Babcock

Mr. Summers turned the floor over to Kaeley Weimerskirch of RBC Capital, who presented the final pricing updates on the General Obligation Bonds Series 2025. She stated the Bloomfield Schools sold \$9,995,000 with the New Mexico Finance Authority on December 16, 2024. Total interest cost came in at 2.98%, which is far below the current 10-year treasury trading at 4%. Closing was on January 10, 2024 and these funds are available to be used on voter authorized projects. Total interest is \$545,979 and the total repayment of this loan will be \$10,540,979. She also provided a payment schedule of these bonds from 2025 through 2036. A schedule of 8 million dollars of principal to be paid upfront in 2025. This concludes the recap of the 2025 bond sale. Ms. Babcock provided the January reports consisting of the consent agenda, revenue and expenditure reports, the monthly check listing and credit card expense reports. She also mentioned the resolution to be signed for the purchase and sale agreement of the property adjacent to MAJH. This agreement is to be signed by the Bloomfield School District Board of Education President, Dale Maes.

Five different vendors will be presenting on February 25-27, 2025 from 3:30pm to 5:30pm. The teachers will make the decision via the rubric scoring.

3.0 DISCUSSION and REVIEW ITEMS

3.1 Equity Council Update - Mr. Summers

Equity Council Members include: Kevin Summers, Dale Maes, Tony DeHerrera, Ben Woody, Jr., David Salcido, Sue Finch, Desiraye Benavidez, Dr. Julie Pierce and Verlynne Platero. All were in attendance except Verlynne Platero. Mr. Summers introduced Dr. Pierce, the new Federal Programs Director, to all in attendance. He mentioned Dr. Pierce has been working with Mrs. Staffa and Ms. Babcock since her arrival. He also mentioned a few short falls with Impact Aid. The Indian Policies and Procedures that is to be approved by the School Board is not on file. Each year a survey is to go out to federally connected students on the 40th day, this survey was not sent out. The last nine application have gone out with data that can't be verified. The deadline for this data has passed, which the school district will suffer a 10% consequence. Dr. Pierce and staff are currently working on the accurate data. Dr. Pierce gave an update on the last IEC meeting. She mentioned they are working on the IPP and have the first signature and will be put on the next Board of Education meeting agenda for approval. Dale Maes provided board members with copies of a few legislative summaries. Mr. Summers mentioned House Bill 65 about instructional hours. Mr. Summers and Board Member Ben Woody, Jr will attend the legislative session later in the week.

3.2 Report & Discussion of District Activities - Mr. Summers

Mr. Summers provided a typed report to the Board members detailing updates for the maintenance department, athletics and personnel news. Mr. Summers turned the floor over to Mrs. Candelaria-Cooper, of 911report.com. She presented on an emergency response system about school safety. A video was played about student safety, 911 stream. She then turned the floor over to Chad Herrera who spoke about the student safety platform and mentioned it can also be school specific. The app will not be controlled by police officials. The app will be controlled by school administrators and others who have permissions. They are wanting to get the app countywide so everyone will be on the same page and utilize the system. Mrs. Candelaria stated there is one platform with two apps for apple and google launched on December 19, 2025. Cost to be around \$20.00 per students, per year. She will present this platform to the Arizona legislation next Thursday.
