

2.13.24-version ONE

The use, possession, or being in the proximity of the use of tobacco, drugs and alcohol [**Board policy J-3000 and J-3050**] by current student athlete(s) will result in: **this would be a continuous progression (from year to year) while the student athlete is in school:**

First Violation - during season and off-season; ON and OFF Campus

- after confirmation of the first violation, the student athlete will be suspended immediately in the activity in which the student is a participant for 10% of the total regular season games. If the violation takes place before playoffs, 10% suspension will carry over into the playoff games until the 10% suspension is served.
- during the suspension period, a student athlete must successfully complete a school approved counseling program (at the expense of the student or legal guardian), prior to participation in a future activity. The student will not be allowed to participate in extracurricular activities until the school administration is given proof of completion of an approved counseling/substance abuse program.

Second Violation - during season and off-season; ON and OFF Campus

- After confirmation of the second violation, the student athlete will be suspended immediately in the activity in which the student athlete is a participant for 25% of the total regular season games. If the violation takes place before playoffs, 25% suspension will carry over into the playoff games until the 25% suspension time is served.
- during the suspension period, a student athlete must successfully complete a school approved counseling program (at the expense of the student or legal guardian), prior to participation in a future activity. The student will not be allowed to participate in extracurricular activities until the school administration is given proof of completion of an approved counseling/substance abuse program.

Third Violation

- After confirmation of the third violation, the student will be suspended from participation in extra-curricular activities indefinitely.

Student athletes that violate the BSD Athletic Policy, will not participate in any team function while serving their suspension. Team function include but not limited to (team camps, team meals, practices etc....)

2.13.24-version TWO

The use, possession, or being in the proximity of the use of tobacco, drugs and alcohol [Board policy J-3000 and J-3050] by current student athlete(s) will result in:

- First Violation - during season and off-season; ON or OFF Campus

 - The immediate suspension, after confirmation, from all athletic participation for a period of (30) school days. (If the athlete is suspended with less than 30 school days left, the remainder of the consequences will carry over the next sport season). In order to provide a progressive and supportive measures, while in suspension, and to promote a positive outcome, student athlete will complete an assessment screening and provide completion agreement and establish a contract with the school administration.

- Second Violation - during season and off-season; ON or OFF Campus

 - A second confirmed violation of this policy will result in suspension from all athletic participation for (60) school days. (If the athlete is suspended with less than 60 school days left of the school year, the remainder of the consequences will carry over the next sport season, including pre-season). The athlete will enroll in counseling with a substance abuse counselor. (At his/her own expense), and must show completion of counseling program before returning to participation.

- Third Violation - during season and off-season; ON or OFF Campus

 - A third infraction will result in removal of all athletic participation for the remainder of the school year or (90) school days. (If the athlete is suspended with less than 90 school days left, the remainder of the consequences will carry over the next sport season, including pre-season). The athlete will enroll in counseling with a substance abuse counselor. (At his/her own expense), and must show completion of counseling program before returning to participation.

Student athletes that violate the BSD Athletic Policy, will not participate in any team function while serving their suspension. Team function include but not limited to (team camps, team meals, practices etc....)

2.13.24-version THREE

The use, possession, or being in the proximity of the use of tobacco, drugs and alcohol [**Board policy J-3000 and J-3050**] by current student athlete(s) will result in:

First Violation

- After confirmation of the first violation, the student will be suspended immediately, for the remaining contests, in the activity in which the student is a participant, or 60 school days, whichever is longer.
- During the suspension period, a student must successfully complete a school approved counseling program (at the expense of the student or legal guardian), prior to participation in a future activity. The student will not be allowed to participate in extracurricular activities until the student athlete has provided proof of completion of an approved counseling/substance abuse program.

Second Violation

- After confirmation of the second violation, the student will be suspended immediately for one year from any BSD junior high or high school level extra-curricular activities. This is one calendar year from the date of violation.

Third Violation

- After confirmation of the third violation, the student will be suspended from participation in extra-curricular activities indefinitely.

Student athletes that violate the BSD Athletic Policy, will not participate in any team function while serving their suspension. Team functions include but are not limited to (team camps, team meals, practices etc....)
