5.0 SUPERINTENDENT'S REPORT/DISCUSSION

5.1 Report & Discussion of District Activities (Including Federal Programs Travel/Training Update presentation - Ms. Marquez) - Mr. Olivas

Mr. Olivas provides updates for the Maintenance Department, Athletic Events, and Personnel News. Including Federal Programs Travel/Training Update Presentation by Ms. Marquez. Mr. Olivas mentioned the initiatives going on around the District. He mentioned ordered and received AED's, HVAC at Blanco and the Bobcat Stadium. Intercoms to be installed at Mesa Alta and BHS. Communication upgrades with District radios. Mr. Olivas also mentioned the new nurse beds at Naaba Ani. The roofing projects at the BHS auditorium and north gym. A new activities bus to arrive mid-March. Mr. Olivas updated on the boys' and girls' basketball, wrestling and MAJH basketball. Mr. Olivas then turned the floor over to Ms. Marquez. Ms. Marquez presented the Federal Programs travel and training updates. She presented a PowerPoint presentation that included Ms. Marquez attended the ISTE Conference June 25th through June 29th, 2022. She provided a full itinerary for the ISTE Conference and keynotes including building inclusive tech plans for school and district leaders, classroom innovations: Microsoft teams for in-person learning, impact of coding on preschooler's math abilities and ESport experience. Ms. Marquez also stated she attended the JOM National Conference September 18th through September 21st, the IEC members, District Native American teachers and Board Member Mr. Ben Woody, Jr also attended. She mentioned this conference is where she learned how to do impact aid funding, write grants and learn what to do to be in compliance. Ms. Marquez mentioned Federal Programs are always changing and going to these conferences help her learn and be in compliance. Mr. Marquez mentioned the upcoming conference she will be attending, the NAEHCY (National Association for the education of Homeless Children and Youth. NAEHCY to help students who are experiencing homelessness. She also mentioned that if any students need help with school supplies, just ask your teacher and they will be able to support. Ms. Marquez provided her CEU credits and certificate of attendance.

6.0 PRESENTATIONS

6.1 Naaba Ani Elementary - Mrs. Webb

Mrs. Webb shared a PowerPoint presentation sharing the progress of Naaba Ani. Mrs. Webb turned the floor over to Grace McFarland to present the first Lego League Robotics Competition Results. She mentioned taking 90 students to attending the regional Robotics Competition on December 10th, 2022 at Tibbetts Junior High in Farmington, NM, Nine teams are going to the state competition on February 11, 2023. The Energise Cheese team was awarded the Champion Award. Ms. McFarland stated lots of learning going on in and out of the classroom with robotics. Mrs. Webb then mentioned the enrollment and class sizes at Naaba Ani. 4th grade enrollment is 141, 7 teachers with an average 20 students per classroom. 5th grade enrollment is 154, 7 teachers with an average of 22 students per classroom. 6th grade enrollment is 140, 7 teachers with an average of 20 students per classroom. Mrs. Webb mentioned including a PowerSchool breakdown to the Board, which includes ethnicities. Next she presented the CIA Comparison Data, NWEA Assessment Data and Imagine Online Program Data. Mrs. Webb mentioned the Fall 90 Day Plan focus areas which are School Culture-Math, Layer 1 Core Instruction-ELA. Mrs. Webb mentioned Professional Development for Write Tools, MC2 Math, Lego Robotics, Unruly Splats, Imagine Online, HMH Reading, Standard Based Grading, 4 Point Grading Scale, Differentiation/Scaffolding and Accelerated Reading. The Educator's Handbook helps utilize the online documentation system to track behaviors/setting and identify the trends and patterns for intervention. Mrs. Webb presented the office referrals and minor incidents for 2018 through 2022. She also mentioned the PBIS which includes greeting students in the morning, daily morning announcements with RISE expectations and weekly Bobcat Bucks and prizes. Naaba Ani continues to communicate with families through parent teacher conferences, Bloomz (Online Platform), monthly newsletters/calendars, robo calls/emails. Mrs. Webb mentioned engaging and support staff by issuing a weekly newsletter, Admin showing appreciation to staff, staff meeting shout outs and monthly birthday celebrations. She also mentioned for family engagement this year Naaba Ani offered a family Thanksgiving lunch and sold 130 tickets. First Annual HERO Fun Run also took place at Naaba Ani and the student had fun. Mrs. Webb shared pictures of the Robotics Competition and the Hero Fun Run. Mr. Olivas acknowledged the school and thanked them for all their hard work.

6.2 Blanco Elementary - Mrs. Spencer

Mrs. Sharpe shared a PowerPoint presentation sharing the progress of Blanco Elementary. Mrs. Sharpe mentioned the demographics at Blanco which included student population, grade levels and ethnicity. BOY and EOY data for grades 1-6 was presented by Mrs. Sharpe. NM-MSSA data shows 50% of 6th grade is proficient in math. Mrs. Sharpe also shared cohort data for 2021-2022. The 90-day plan will focus on Tier 1 ELA instruction and Tier 1 math instruction. She also shared pictures of professional development in Choral Counting, Write Tools, Tutoring and Learning camps, and PBIS. Mrs. Sharpe mentioned Blanco's family engagement includes open house, "Counting Collection", classroom dojo, google classroom and parent teacher conferences. Mrs. Sharpe introduced several Blanco teachers that are in attendance. Mrs. Shape turned the floor over to several Blanco students and Mr. Notah who then presented "Number Talks" to the Board. Mrs. Sharpe mentioned she is thankful for the Blanco staff and students.

6.3 BHS Football Recognition - Mr. Maes

Mr. Olivas turned the floor over to Mr. Maes. Mr. Maes mentioned he invited the BHS Football Team to recognize them for winning the state championship and also to show them the process of the School Board meetings. School Board Members and Cabinet then introduced themselves with brief description of what each person's job is within the District. Mr. Maes presented the BHS Bobcat Football Team with a State Champions banner.
