****Proposal for Transitioning to a 6-Period School Day****

Charlie Y Brown High School would like to propose transitioning from a 5-period school day to a 6-period school day. This transition is designed to provide multiple benefits to both students and educators. The primary advantages include increasing the number of credits students can earn, accommodating dual-credit classes, and reducing downtime during class hours. In addition to the benefits already mentioned, BHS students would have a chance to take dual credit classes locally. This proposal outlines the rationale and key benefits for this transition.

1. ****More Credits for Students:**** A 6-period school day allows students to enroll in additional courses, increasing their opportunities to earn credits. This is particularly beneficial for students aiming to graduate early, pursue advanced coursework, or explore various subjects.
2. ****Dual Credit Classes:**** Many students today are interested in taking college-level courses while still in high school. A 6-period schedule makes it easier to incorporate dual-credit classes, enabling students to earn both high school and college credits simultaneously, reducing the overall time and cost required to complete higher education.
3. ****Reduced Downtime:**** With a 6-period schedule, students and teachers will experience less downtime during the school day. The shorter class periods can be utilized more effectively for instruction, collaborative activities, and in-depth discussions, enhancing the overall quality of education.
4. ****Local Dual Credit Option:**** Students from CYB as well as BHS will have the option to take Dual Credit courses locally and in person, instead of traveling to San Juan College or taking the class online.

Transitioning from a 5-period school day to a 6-period day offers numerous benefits, including increased credits for students, the inclusion of dual-credit classes for both campuses, and reduced downtime during class hours. By carefully planning and implementing this transition, we can provide students with a more comprehensive education and better prepare them for success in college and their future careers. We look forward to discussing this proposal further and working collaboratively to enhance the educational experience in our school.

****Proposal for a bus route from CYB to San Juan College****

Charlie Y Brown High School would like to propose adding a bus route from CYB to SJC. This route would be an extension of the route that leaves BHS after 1st period. This route would leave CYB at approximately 10:00 to San Juan College. Students would then be able to take various dual credit classes offered at SJC. The bus would then depart San Juan College at approximately 1:30 to transport students back to CYB / BHS. This proposal outlines the rationale and benefits of this route.

1. ****More Opportunities for Students:**** This bus route would open up a lot more opportunities for students to take Dual Credit classes at San Juan College. Both BHS and CYB students who do not have their own transportation would have access to classes that they normally would not be able to take.
2. ****Less Online Classes:**** This bus route would reduce the need for students to take Dual Credit classes online, and would help to fulfill the state mandated requirements for dual credit classes for those students who do not have an honors, advanced placement, or distance learning class.

Offering a bus route to San Juan College would benefit students in a multitude of ways. Students from both CYB and BHS would be able to take classes that are offered only at San Juan College. Students without their own transportation would be afforded the opportunity to take classes for dual credit. Students learn better in face to face classes. By offering this route, more students could access teachers in person, rather than taking a class online. We look forward to discussing this proposal further and working collaboratively to enhance the educational experience in our school.
